Proceedings of the 15th Annual General Meeting of the Members of Mahindra Rural Housing Finance Limited held today i.e. on Friday, 22nd July 2022, at 5.00 p.m. (IST) at Registered Office of the Company at Mahindra Towers, P. K. Kurne Chowk, Worli, Mumbai - 400 018, pursuant to Regulation 51(2) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with clause (23) of Part (B) of Schedule III of the said Regulations.

The 15th Annual General Meeting ("AGM") of the Members of Mahindra Rural Housing Finance Limited ("the Company") was held today i.e. on Friday, 22nd July 2022, at 5.00 p.m. (IST) at Registered Office of the Company at Mahindra Towers, P. K. Kurne Chowk, Worli, Mumbai - 400 018.

Mr. Ramesh Iyer, Chairman of the Board of Directors, chaired the Meeting. The requisite quorum being present, the Chairman called the Meeting to order.

The Chairman introduced himself and welcomed the Members present at the Meeting. The Chairman informed the Members about Directors who could not attend the meeting due to prior commitments and they were granted leave of absence. The Managing Director, the Company Secretary & Compliance Officer and the Chief Financial Officer of the Company were present at the AGM.
